1. Welcome and Introduction of Board of Examination Members

- Meeting is opened by Dr. Anishkumar Karia, Member Secretary, CoE-SBPIM by welcoming the all members of Board of Examination.
- Dr. Anishkumar Karia introduced all the members of Board of Examination and briefing the autonomy journey of SBPIM and agenda of the meeting.

2. Overview and Approval of Examination Committees

- Dr. Anishkumar Karia presented the proposed list of Examination Committees for the current academic year, detailing the constitution, roles, and responsibilities of each committee.
 - o Complaints Redressal Committee (CRC)
 - o Examination Remuneration Committee (ERC)
- Dr. Prabhakar Desai suggested to prepare Lapses Committee to ensure the integrity of examinations.

Resolution: It was resolved to form Complaints Redressal & Lapses Committee (CRLC) instead of Complaints Redressal Committee (CRC).

3. Discussion and Approval of Examination Scheme:

- Dr. Anishkumar Karia explained Examination Scheme, including the Formative Assessment (FA) / Continuous Internal Evaluation (CIE) and Summative Assessment (SA) / End Semester Evaluation (ESE) and its applicability to various types of courses.
- Members discussed scheme in details and further clarity was given by Dr. Kirti Dharwadkar and Dr. Amarish Padma.

4. Discussion and Approval of Rules & Regulations for Examination & Evaluation:

- Dr. Anishkumar Karia elaborated following Rules & Regulations for Examination & Evaluation
 - o Rules of Progression, Rules of Allowed To Keep Terms (A.T.K.T.)
 - o Performance Indices, Grading System
 - Special Examination of Summative Assessment / End Semster Evaluation
 - o Guidelines against Unfair Means / Malpractices during Examinations
 - Revaluation of Answer Book
- Dr. Prabhakar Desai recommended to provide a chance to students who failed or remain absent for regular examination by conducting re-examination apart from special examination.

Resolution: It was resolved to conduct re-examination instead of special examination for students awarded with "F" and / or "Ab" Letter grade with Grade Penalty except student who represented institute at research, sports, curricular, etc. competitions and / or appearing for competitive examination like UPSC, MPSC, etc.

5. Discussion and Approval of Ordinances for Examination & Evaluation:

- The proposed Ordinances covering broader statutory provisions and institutional norms related to examinations and evaluation were reviewed.
 - Ordinances were
 - Ordinance 1: Grace Marks
 - Ordinance 2: Moderation
 - Ordinance 3: Vigilance Squad
 - Ordinance 4: Amendment of Results
 - Appointment of Paper setters, Examiners, Senior Supervisors, Conduct of Examination etc.
 - Ordinance 6: Regarding unfair means resorted to by the student
 - Ordinance 7: Providing of additional facilities and benefits to person with disability (PwD) / Specially Abled students
- Members suggested ensuring consistency with University/Regulatory Authority guidelines.
- Dr. Prabhakar Desai signified the importance of student's participation at University, National and International Level activities, he advised to adopt Ordinance 163 of SPPU for Grant of additional marks for extra-curricular activities.

Resolution: It was resolved to incorporate Ordinance 163 of SPPU for Grant of additional marks for extra-curricular activities.
