**Objective: Fair Admissions process for deserving Candidates**

SBPIM admission policy Process is in accordance with the government norms.

### **1. Pre Centralized Admission Process:**

Maharashtra MBA Admission is conducted on the basis of an entrance exam. The Maharashtra Common Entrance Test (MAH CET) is the annual state-level common selection test for admission to MBA programs offered by participating universities of Maharashtra. It is officially known as MAH MBA/MMS-CET. The MAH MBA CET Application Form has been released to offer Maharashtra MBA Admissions through the MAH-CET every year in the second half of every year.

Maharashtra MBA Admission process is conducted by The Commissionerate, Common Entrance Test Cell, Mumbai. The entrance test is conducted across 47 urban areas in the state of Maharashtra. MAH CET MBA is followed by the Centralized Admission Process (CAP) counseling in which the candidates will be allotted MBA seats in MAH CET participating colleges based on their scores.

Candidates holding a graduation degree from a recognized college are qualified for confirmation through MAH CET. The candidates should score the % as decided by SRA on time to time for admission to the MBA course in Maharashtra. MAH-CET score is accepted by more than 300 public/private business schools in Maharashtra.

SBPIM conduct CET exam awareness sessions online for the students who have registered for CET.

In this SBPIM faculty deliver the session on tips to solve CET paper in stipulated time. It includes English language, Reasoning and Aptitude Test with example. At end of the session SBPIM give them practice test also to get hands on experience.

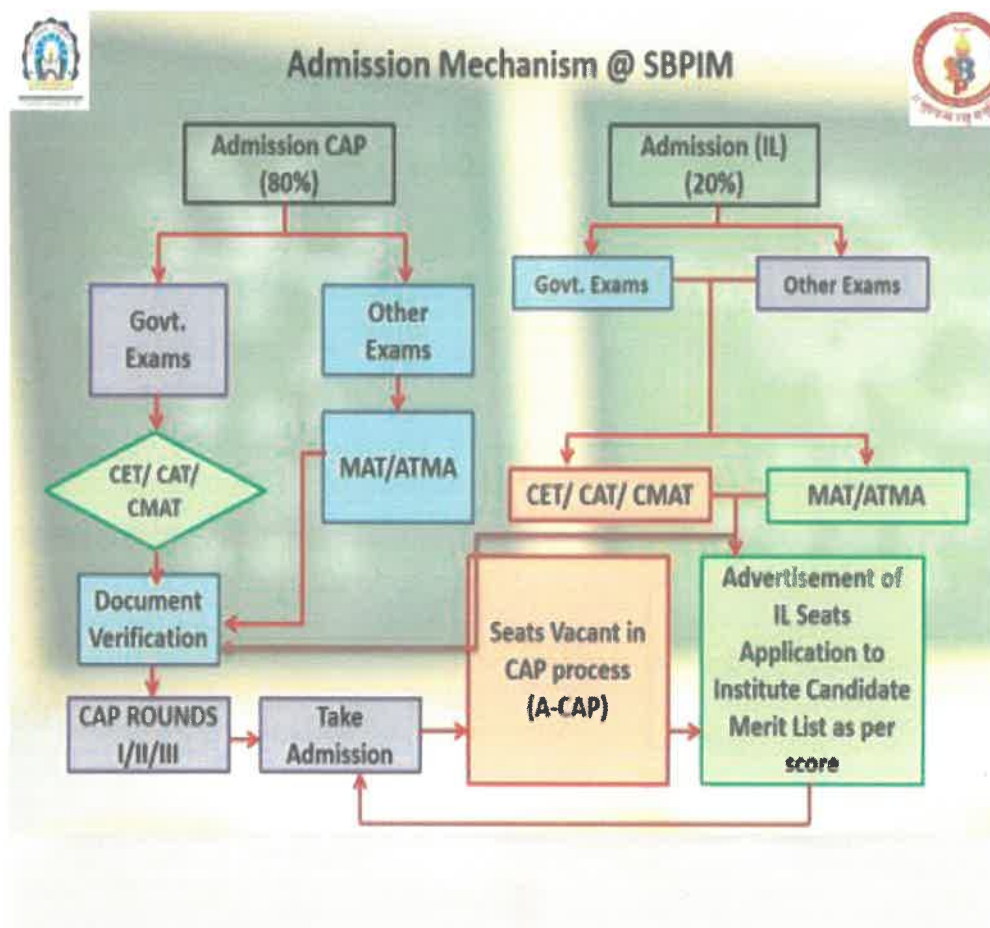

### **3. Post CAP Admission Process:**

Once the all the students confirm the admission at the institute he/she has to submit the set of his/her original documents in the institute for DTE merit list verification and University eligibility process. Institute take utmost care of the students documents till it is with the institute.

### **4. Scholarship Process:**

The students admitted under various reserved categories are eligible for various state and central government scholarship schemes. Once the MAHADBT and Central Govt. portal get opened the students are informed to fill the scholarship forms. Students who are eligible for EBC scholarship under open category also informed to fill the form for scholarship.

### **5. Admission Cancellation Process:**

Students who confirm the admissions during the CAP round I/II/III are eligible to cancel the admission as per DTE norms before the final cut-off date by paying the prescribed charges decided by DTE.
