The question of how best to fund the circular economy is receiving increasing attention not only from circular economy proponents, but from policymakers and the finance sector. Circular economy finance is becoming more sophisticated due to the growing demand for sustainable finance from investors and company shareholders. — Despite recent growth, circular economy finance and spending remains small-scale in comparison both with other green finance and with spending in the linear economy. Current investment levels are too low to drive a global circular economy transition at scale. — The current roll out of recovery and economic stimulus packages in response to the COVID-19 pandemic provides an opportunity to accelerate a 'just transition' to an inclusive circular economy. So far, economic stimulus packages have predominantly been allocated to support the existing linear economic system, rather than to investing in transformation towards a sustainable economy.

Your full paper/extended abstract should cover the following aspects (a) Introduction (including research question), (b) Literature Review, (c) Propositions or Hypothesis (if any), (d) Research Methodology, (e) Analysis, Results, (f) Implications, (g) Conclusions (including contribution of the study), (h) Limitations, (i) Future research possibilities, and References.

4. All submissions should be in Times New Roman, 12-point size, single-spacing, with 1 inch margin on all sides, Heading (s) must be short, with a clear indication of the distinction between the hierarchies of headings.
5. Note: Abstract/Full Paper that does not follow the above instructions will NOT be reviewed
