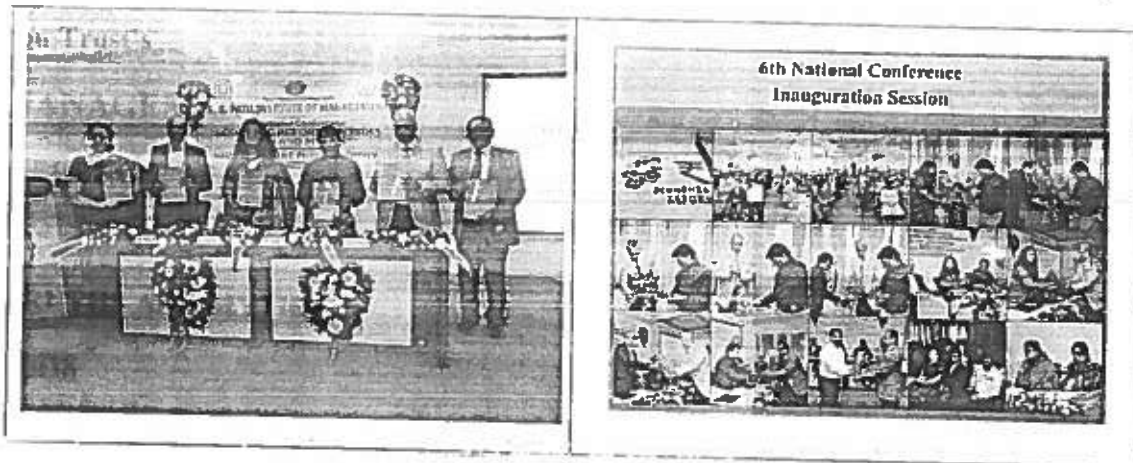
Inaugural Program:

SESSION – III

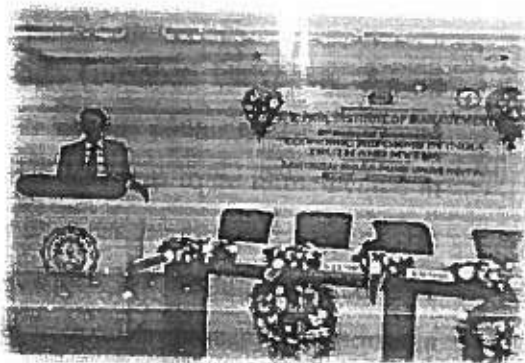

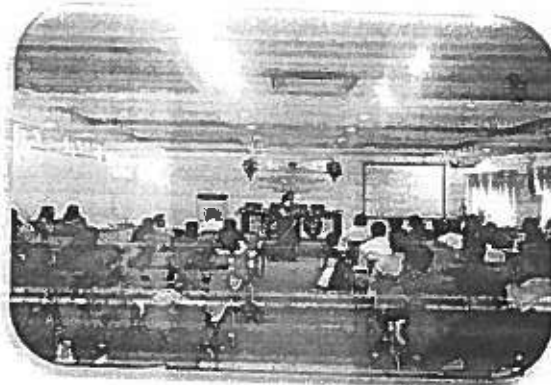
DAY-2

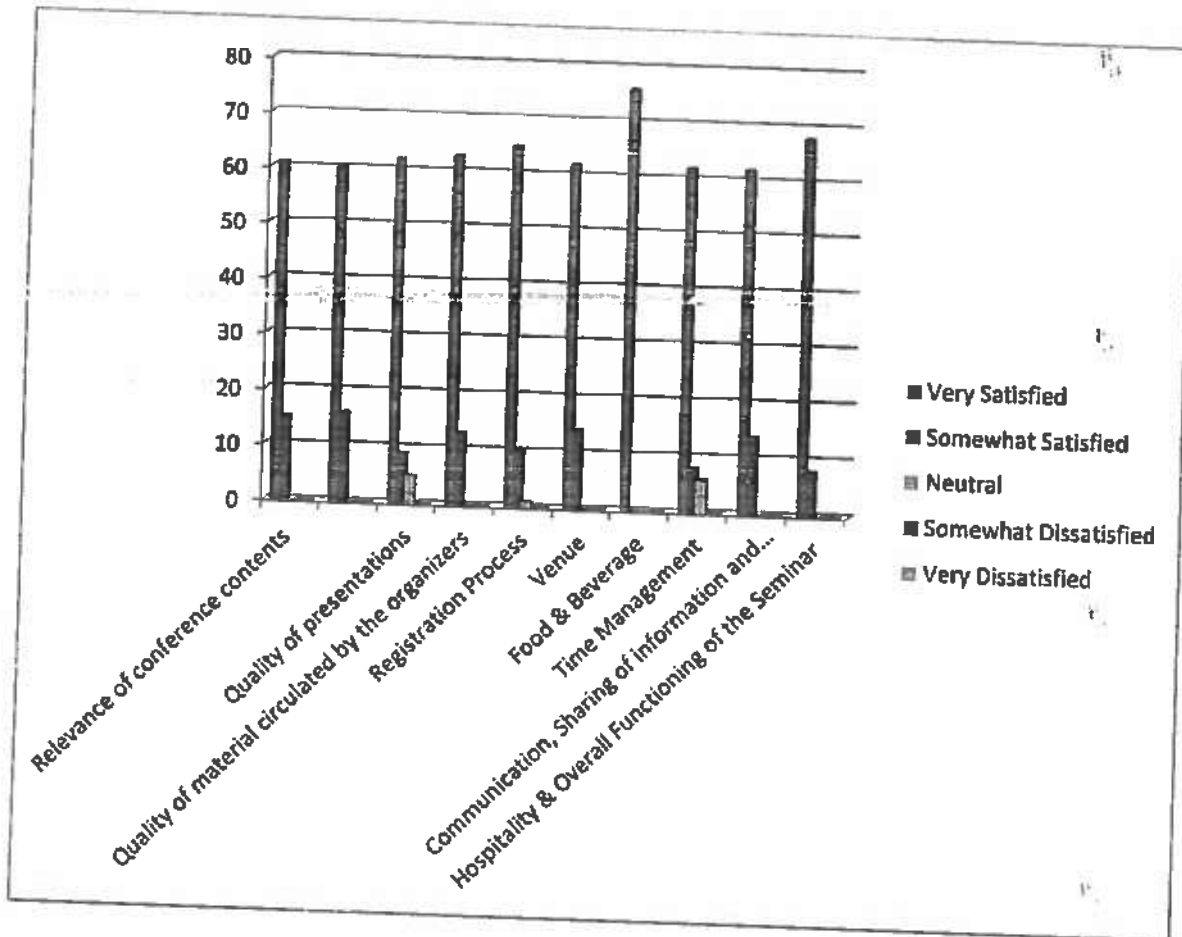
