Patil Institute of Management, Sector No.26, Pradhikaran, Nigdi, Pune – 411 044 in the pay scale of Rs. 37400-67000 plus AGP Rs.9000 with effect from 01st March, 2023 or date of your joining.

1. Your services will be governed by the Maharashtra Public University Act 2016, Statute Code of Conduct, Ordinances and rules and regulations laid down by the University of Pune and State Government from time to time.

 - b. The post is available for SC. Since you belong to the SC category, you are appointed on full-time basis on probation for a period of one year from the date of your joining.
2. You will be paid Basic Pay of Rs. 37,400/- per month in the scale indicated above. You will also be entitled to Dearness Allowances, House Rent Allowances and C.L.A. at the rates prescribed by the state Government from time to time. Your appointment and salary shall be subject to the approval by the Savitribai Phule Pune University, Pune.

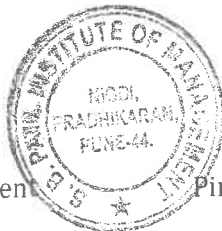

 - b. Character Certificate from two eminent persons, one of them should be a Govt. Gazetted officer.
 - c. Discharge Certificate from previous employer (if any).
7. You will have to undergo medical examination by the approved Medical Officer or by the Civil Surgeon at the place of your duty, within three months from the date of joining the duties. The appointment shall be provisional and conditional, pending submission of medical certificate stating that you are physically fit for employment on the staff of the college/institution.

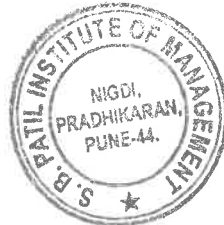
